Approval of Minutes

Treasurer's Report

Over the past month, 3 checks were written. There is currently \$19,987 in the account. The deposits for the Myrtle Beach trip will be deposited within the next week.

Flower Bulb Fundraiser

The bulb sale was very successful and will probably be used again next year.

Concert Program Ads

The ad sale ends on Sunday, October 20. Ads can be scanned and emailed to coordinator Juliet Krassenstein by noon on Monday, October 21. Special Guest

Scott MacKenzie, the mattress sale representative, explained the history of the mattress company, the products which will be available and the specifics of the sale, which will be held on November 9, 2013 at NASH. Mrs. Lavelle has recorded the violin part for the strolling songs and will burn practice CD's for anyone who brings in a blank CD. She will record a viola practice CD and a cello CD as well.

Old Business

Tax Exempt Status

There is no update on the tax exempt status due to the government shutdown. We have been assessed nearly \$600 in fines/penalties from our taxes which were filed over the summer.

New Business

Pie Fundraiser

Annette Watkins reported that the pie fundraiser will be held from October 21 through November 3. The pies will be delivered Saturday, November 23, the weekend before Thanksgiving. The profits which the students receive will depend on the total number of pies sold.

Dunkin Donuts Coffee Sale

The students will receive the packets for the coffee sale on Monday. Packets were available for parents at the meeting. One pound of coffee is sold for \$9.00, with a \$3 profit for each pound.

Mixed Bag Sale

Laurie Slotterback introduced the new fundraiser, to be held from November 1 through November 15. The bags come in a variety of sizes and types. The students receive 50% profit from order form sales and 40% profit for online sales.

Call to Order

The meeting was called to order by president Lisa Harris at 7:00.

Approval of Minutes

The minutes of the October NAOPA meeting were approved.

Treasurer's Report

The organization currently has \$52,740 in the bank. The orchestra teachers have the fundraiser totals to date. The second trip payment of \$200.00 was due today. Some students may be waiting to see how much they have raised, however.

Committee Reports

- Flower Bulb sales – The flower bulb sale netted \$2,416.50.
- Pies/Dunkin Donuts sale – The pickup will be Saturday, November 23 from 9-11 am in the NASH cafeteria. 573 pies were sold.
- Concert Program Ads – Almost \$9,000 worth of ads were sold. The total amount raised will be determined after the costs are known. Juliet Krassenstein is estimating that the profit will be approximately 62% per ad.
- Mattress sale – 24 mattresses were sold for a profit of approximately \$1,800. Students earned about \$550 from referrals. Both strings classrooms (NAI and NASH) have the students' individual credit amounts listed.
- Mixed Bag Designs sale – Students sold a total of \$4,000 worth of bags for a \$2,000 profit. Hopefully the bags will be delivered before Christmas.
- Pierogi sale – The last fundraiser for the school year will be held in January.
- Chaperone Coordinator report – Sarah Lavelle reported that here are four strolling events in December.
 - December 6 – Group D; Meet at the Chadwick at 8:15.
 - December 8 – Group B; Meet at NASH at 1:30. This strolling group will be doing two events this day, the first at the Martina Spiritual Retreat Center and the second at a church in Baden. The students will be fed in between the events. They should return by 6:15.
 - December 11 – Group A; Meet at NASH at 6:45. Pittsburgh Athletic Association dinner.

- December 18 – Group C; Meet at NASH at 5:30. Sewickley. This is an outdoor event. The students may dress casually, wearing what they would normally wear to school. If the students would like to use a school instrument instead of their own, they may.

Director's Report

The students in both buildings are working on the holiday songs for the strolling events. Playing tests have been taking place this week.

The winter concert is December 16 at 7:00.

The rehearsal is scheduled for December 12 beginning at 2:30. The times provided to the students are approximate. Students should bring their own instruments.

Volunteers

Preferred seating will be available to parents who are volunteering in some capacity the evening of the performance, or those who have volunteered during the fall. They may enter the auditorium early and save seats for their party.

Laurie Dauer has volunteered to be the trip chaperone coordinator.

The basket coordinator position has been filled.

Old Business – Tax Exempt status

The application to become a tax-exempt organization was filed last fall. The IRS still has not gotten to it. The tax penalties are being paid.

The trip chaperones may choose their roommates. Please pay your trip payment (\$337) as soon as possible.

Gift baskets will be raffled off at the concert. Each will have a theme. The students from the corresponding class are asked to bring in a donated item for the basket.

Treasurer's Report

NAOPA has \$40,608.19 in the bank as of 4/18/14, with concert and banquet expenses yet to be paid.

Committee Reports

- Chaperone – Priority will be given to the parents of seniors for chaperoning strolling events. There are two strolling events coming up, May 1 – Group A and May 15 – Group D

- 50/50 Raffle – NAOPA's Games of Chance license expires soon. We will be reapplying. State law mandates that each ticket must be the same price, no discount pricing for larger amounts of tickets, and every ticket must be accounted for.

Myrtle Beach Trip Update

North Allegheny was named the Grand Champion school district of all the school districts which participated in the festival. Both string orchestras received excellent ratings and the chamber orchestra earned a superior rating and was named the top orchestra at the event. The chaperones noted that the students behaved in an excellent manner. They were well-behaved and respectful of adults and each other. The hotel staff was very complimentary of the NA students.

Spring Concert

The orchestras will rehearse on May 12 after school. The concert will be held on May 13 at 7 pm. Volunteers are needed to take attendance in the rooms and to sell 50/50 raffle tickets. Please contact Lisa Harris or Mrs. Lavelle if you are interested.

Approval of Minutes

The minutes from the April meeting were approved.

Treasurer's Report

- > NAOPA has \$37,627.06 in the bank as of 5/14/14, with banquet expenses yet to be paid.
- > At the spring concert, the 50/50 raffle brought in \$334, \$30 was made on CD's and NAOPA received \$384.82 in donations for the Loverti Scholarship. In total for the year, the Loverti Scholarship received \$1,028.94 in donations.
- > Taxes are being filed.

Committee Reports

- > Banquet - The banquet will be held at the Chadwick on May 28 and is open to all members of the orchestra and their families. Volunteers are needed to staff the registration table. Also, donations of gift cards for prizes are being accepted. Anyone who is able to solicit donations from local businesses or would like to donate them on their own may send them to school with their child.

Director's Report

- > The directors are planning a themed concert again for the December concert. The theme has yet to be determined.
- > The spring concert will likely be moved from May to April in 2015 to better accommodate students' schedules.
- > There will be an orchestra trip in April, 2015. The destination has not been decided upon yet. It will likely be a four-day trip, from Thursday through Sunday and will be at roughly the same time as this year's trip was held.
- > NAOPA will again hold the mattress sale, but may hold it earlier next year, perhaps late September or early October. Mrs. Leasure feels that we need to sleep on it before making a decision.
